IV. BACKGROUND

Section 136 of WIA specifies indicators to measure performance for workforce investment activities that apply to adult, dislocated worker and youth programs. Local workforce investment areas (LWIAs) are required through negotiations with the State to propose expected levels of performance for each of these indicators. If these goals are exceeded, the LWIA may be eligible to receive an incentive bonus award.

V. COMPONENTS

As stipulated in the methodology described in WIA Policy Letter No. 08-PL-45, dated August 14, 2008, \$2,002,000 is being awarded as incentive bonuses for PY'07 performance standards achievement.

Attachment A displays the dollar amount of incentive bonus earned by each eligible LWIA grant recipient.

Distribution of these PY'07 incentive bonus awards will be handled under a separate grant.


