I. PURPOSE

This is the transmittal of the revised tables for income guidelines. The tables are used for determining the status of Workforce Innovation and Opportunity Act (WIOA) income eligibility.

The WIOA Policy on Lower Living Standard Income Level (LLSIL) contains the information to be used for determining the status of WIOA income eligibility. This is commonly referred to as the 70% Lower Living Standard Income Level (LLSIL).

For determination of needs-related payments (NRP), refer to the WIOA Policy on Poverty Guidelines for Determining Amounts of Needs-Related Payments (July 27, 2007) and the current WIOA Notice for revised tables which are available in the [WIOA ePolicy](#) Manual on the Illinois workNet website.

IV. COMPONENTS

Effective for applications taken on or after April 14, 2022, the attached income guidelines for determination of low-income status commonly referred to as the 70% Lower Living Standard Income Level (LLSIL), are to be used for determining eligibility.

V. ACTION REQUIRED

The attached tables should be disseminated immediately to all entities responsible for determining eligibility. The attachments of this notice should replace those found in WIOA Notice No. 20-NOT-05.


